(i) That I have read all the provisions of the NCTE Act, Rules & Regulations. The application of the institution has been submitted as per the provisions of the NCTE Regulation, 2009. That the institution of the management shall be run under (self finance scheme).

(ix) That there shall be reservation of seats for SC/ST/OBC other categories etc. as per the policy of State Govt.

(x) That the supporting and other staff will be appointed as per the guidelines of the State Govt./the affiliating University.

That the institution shall charge only such fee as prescribe by the affiliating State Govt. concerned in accordance with provision of NCTE (guidelines for Regulations of tuition fees and other fees chargeable by unaided teacher education Institutions) Regulation, 2002, as amended from time to time and shall not charge donations, capitation fee etc. from the students.

(xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt/University from time to time through bank.

(xv) That the accounts of the institution will be properly maintained and audited annually by the audit authorities or a Chartered Accountant, and will be open for inspection.

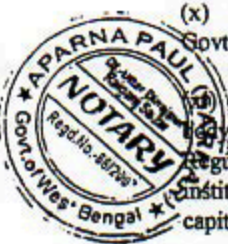
